WAIVER AND RELEASE OF LIABILITY

INSURANCE-GRADE ASSUMPTION OF RISK, RELEASE, AND INDEMNIFICATION AGREEMENT

PLEASE READ CAREFULLY. THIS DOCUMENT WAIVES SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE AND THE RIGHT TO A JURY TRIAL.

In consideration of being permitted to participate in events hosted by **Pixel Peak LAN LLC, a Utah limited liability company** ("Company"), including activities at SpyHop in Salt Lake City, Utah ("Event"), Participant agrees as follows:

1. EXPRESS ASSUMPTION OF RISK

PARTICIPANT EXPRESSLY ACKNOWLEDGES AND AGREES THAT PARTICIPATION IN THE EVENT INVOLVES INHERENT AND SIGNIFICANT RISKS, INCLUDING BUT NOT LIMITED TO PERSONAL INJURY, DEATH, PROPERTY DAMAGE, THEFT, ELECTRICAL HAZARDS, EQUIPMENT MALFUNCTION, DATA LOSS, NETWORK FAILURE, ACTS OR OMISSIONS OF OTHER PARTICIPANTS, AND NEGLIGENCE OF THE COMPANY. PARTICIPANT VOLUNTARILY AND KNOWINGLY ASSUMES ALL SUCH RISKS, KNOWN AND UNKNOWN, FORESEEABLE AND UNFORESEEABLE.

2. FULL RELEASE AND WAIVER OF LIABILITY

Participant irrevocably releases, waives, discharges, and covenants not to sue Pixel Peak LAN LLC, including its members, managers, officers, employees, volunteers, sponsors, agents, venue partners (including SpyHop), affiliates, and insurers ("Releasees"), from any and all claims arising out of participation in the Event, INCLUDING CLAIMS BASED ON NEGLIGENCE OR INCLUDING GROSS NEGLIGENCE TO THE EXTENT PERMITTED BY LAW, to the fullest extent allowed under Utah law.

3. INDEMNIFICATION AND DEFENSE

Participant agrees to indemnify, defend, and hold harmless Releasees from any claim, liability, damage, loss, or expense (including attorney fees) arising from Participant's conduct, rule violations, or damage caused by Participant.

4. MEDICAL AUTHORIZATION

Participant authorizes emergency medical treatment and assumes full financial responsibility for resulting care.

5. MEDIA RELEASE

Participant grants unrestricted rights to use images, recordings, or likeness for promotional purposes without compensation.

6. RULES AND REMOVAL

No illegal downloading. No alcohol or marijuana. Compliance with all rules required. Company reserves sole discretion to remove Participant without refund.

7. ADDITIONAL INSURED ACKNOWLEDGMENT

Participant acknowledges that SpyHop and its officers, directors, employees, and agents are intended third-party beneficiaries of this Agreement and are included within the definition of Releasees.

8. BINDING ARBITRATION

Any dispute arising out of or related to this Agreement or the Event shall be resolved exclusively through binding arbitration in Salt Lake County, Utah, administered under applicable Utah arbitration law. Participant waives the right to bring or participate in any class action.

9. WAIVER OF JURY TRIAL

To the fullest extent permitted by law, Participant knowingly and voluntarily waives any right to trial by jury in any proceeding arising out of this Agreement.

10. ELECTRONIC SIGNATURE CONSENT

Participant agrees that electronic signatures and digital acceptance of this Agreement shall be legally binding and enforceable as original signatures.

11. GOVERNING LAW; VENUE

This Agreement is governed exclusively by Utah law. Exclusive venue shall be Salt Lake County, Utah.

12. SEVERABILITY

If any provision is deemed unenforceable, the remainder shall remain in full force and effect.
